Sweden Online Gambling Systems Certification Scheme

1 Introduction

Swedish Gambling Authority (SGA) requires the online gambling operators to get their online gambling systems certified against SGA's regulations and technical requirements in accordance with ISO/IEC 17065 standard (ISO 17065). This includes testing and inspection of online games (including random number generators (RNG)), gambling systems, and security assessment of gaming operations.

Gaming Associates Group of companies comprises of Gaming Associates AB (**ga**) and Gaming Associates Europe Limited (GA EU).

GA EU provides compliance testing and inspection services to the online gambling jurisdictions around the world. GA EU is accredited for ISO/IEC 17025:2005 (ISO 17025) for testing online games (including RNG) and gambling systems. GA EU is also accredited for ISO/IEC 17020:2012 (ISO 17020) for inspection of online games and gambling systems by UKAS. The following reports are provided by GA EU:

1. Test reports for online games, RNG, and gambling system as per ISO 17025
2. Inspection reports for online games and gambling system as per ISO 17020

ga, as an ISO 17065 certification body, performs the following certification activities against SGA's regulations and technical requirements in accordance with ISO 17065 standard.

1. Perform security assessment as per ISO17065
2. Review test reports issued by GA EU or another ISO 17025 accredited test laboratory
3. Review inspection reports issued by GA EU or another ISO 17020 accredited inspection laboratory
4. Decide on certification and issue certification

The details of the certification scheme for online gambling systems are provided below.

1.1 Online gambling systems certification scheme

1.1.1 Scope of certification scheme

Swedish Gambling Authority (SGA), the gaming regulator in Sweden, has issued regulations and general advice on technical requirements and accreditation of bodies for inspection, testing and certification of gambling service providers. These regulations require inspection, testing and certification against SGA regulations in accordance with ISO 17065.

The certification is performed against the following SGA regulations and technical requirements:

- The Swedish Gambling Act (SFS 2018:1138);
- The Swedish Gambling Ordinance (SFS 2018:1475);

- The Swedish Gambling Authority’s regulations and general advice on technical requirements and accreditation of bodies for inspection, testing and certification of gaming service providers (LIFS 2018:8);
- The Swedish Gambling Authority’s regulations and general advice on state lotteries and lotteries for matters of public interest (LIFS 2018:4), and
- The Swedish Gambling Authority’s regulations and general advice on responsible gambling (LIFS 2018:2).

1.1.2 Type of ga certification scheme

The following certification scheme, Type 6 scheme for certification of services and processes based on ISO/IEC 17067:2013 (ISO 17067), has been selected for certification of online gaming systems against SGA regulations.

This scheme (Type 6) is applicable to certification of services and processes. Although services are considered as being generally intangible, the determination activities are not limited to the evaluation of intangible elements (e.g. effectiveness of an organisation's procedures, delays and responsiveness of the management). In some situations, the tangible elements of a service can support the evidence of conformity indicated by the assessment of processes, resources and controls involved.

For both services and processes, the surveillance part of this scheme includes applicable audits of the management system and assessment of the services or processes.

The security assessment is performed by ga as per ISO 17065 while testing and inspection is performed by GA EU as per ISO 17025 and 17020 respectively. ga reviews testing and inspection reports issued by GA EU and other conformity assessment bodies (CAB's) as part of the overall certification assessment against SGA regulations and technical requirements.

1.1.5 Certification process

The following flow charts depict the processes adopted by ga for certification in accordance with the "ga Sweden Online Gambling Systems Certification Scheme" described above. Please note that the submission for certification (apart from certification application) expected from the client includes (but not limited to):

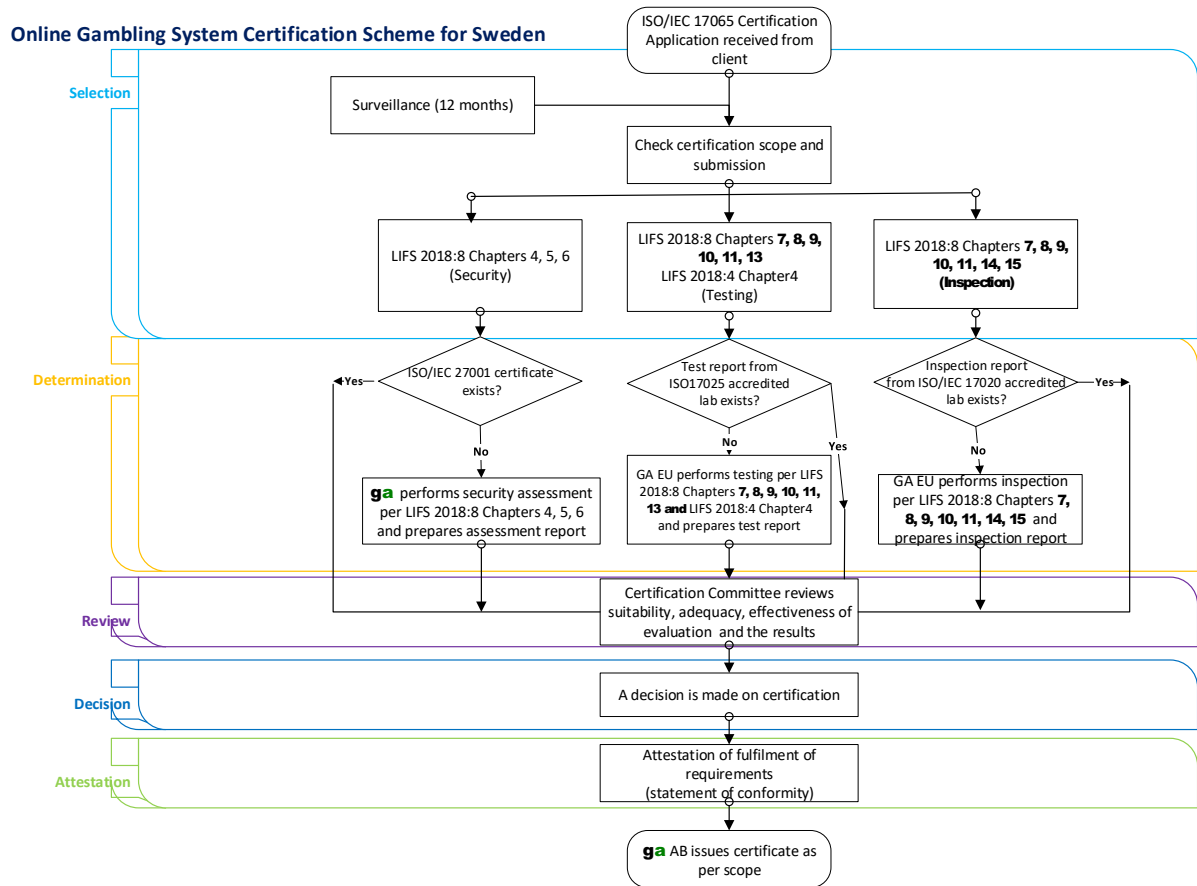
1. Documentation for games including game rules, pay-tables, game maths, mapping table, etc.
2. Gambling System documentation including operational manual, functional description; and policies, procedures for gambling operations
3. Test system for remote testing/inspection of games and gambling system including game play simulation tool if available
4. Production environment network and connectivity diagram including third party connectivity
5. Security documentation including security policy, security controls, etc.
6. Supervised remote access to proposed production environment for security assessment tasks

1.1.6.4 Certification requirements

The certification is performed against SGA regulations and technical requirements for online gambling systems in accordance with ISO/IEC 17065. The requirements are published on SGA website. The SGA regulations and requirements are similar to the requirements laid out by other online gaming jurisdictions around the world and **ga** and GA EU have the required expertise and skillset for testing, inspection, and security assessment of online gambling systems.

1.1.6.5 Certification system

The following evaluation methods are used in order to determine conformity of online gaming systems:

- a. testing
- b. inspection
- c. design appraisal
- d. assessment of services or processes
- e. other determination activities, e.g. verification

The SGA has advised these evaluation methods in its documents and also imposed the requirement of annual periodic evaluation. **ga** maintains records of certification for its client and will contact them before the certification expiry date.

Due to nature of online gaming systems, the SGA has change management requirements included in its technical requirements. The clients will be evaluated for compliance with change management requirements as part of security assessment under this scheme. The client will follow this approved change management process.

1.1.6.6 Conditions

The definition of nonconformity is in line with ISO/IEC 17065 and related ISO/IEC standards. **ga** has defined the following:

- a. criteria for granting, maintaining, expanding, reducing, extending, suspending or revoking certification;
- b. complaints and appeals process;
- c. records kept demonstrating compliance with the requirements; and
- d. rights and obligations of **ga**, clients, and the applicants.

1.1.6.7 Procedures

The certification processes have been described in our management system. The procedures for testing and inspection have been reviewed by UKAS under ISO/IEC 17025 (testing) and ISO/IEC 17020 (inspection) accreditation.

1.1.6.8 Expertise

ga and GA EU have vast experience in evaluation of online gaming systems against the requirements of online gaming jurisdictions around the world. GA EU is accredited by these jurisdictions. This includes evaluation of games, RNG, game math, gaming platform, player registration and account management, responsible gambling, player protection, etc.

ga and GA EU also have experience in information security and GA EU is approved by Payment Card Industry (PCI) Security Standards Council (SSC) as Qualified Security Assessor (QSA) and Payment Applications QSA (PA-QSA). We also provide other information security services such as risk assessment, vulnerability scanning, penetration testing, network reviews etc. Our staff holds international information security certifications such as WLA Security Control Standard Auditor, CISSP, ISO 27001 Lead Implementer, ISO 27001 Lead Auditor, CISSP, CISA, PCI QSA, PCI PA-QSA, CISM, CRISC, etc.

Competency requirements have been defined and assessed for certification auditors, decision makers, and staff performing other tasks related to testing, inspection, and certification. The competency requirements have been established based on SGA regulations and technical requirements and the certification standards.

1.1.6.9 Public nature

The scheme documents are made available to public upon request. Information about details such as evaluation procedures, rules and procedures for granting, for maintaining, for extending or reducing the scope of, for suspending, for withdrawing or for refusing certification are made available to clients upon request.

ga shall keep a list of certified products which can also be made available upon request.

1.1.7 Acceptance of conformity assessment results

ga shall accept results from Conformity Assessment Bodies (CABs) accredited by any EA MLA signatory (for the relevant scope) which follows the requirements laid down by **ga** in the capacity of scheme owner. These results include:

1. security assessment (ISO 27001 certificate) issued by CAB accredited for ISO/IEC 17021-1 and ISO/IEC 27006,
2. test reports issued by CAB accredited for ISO/IEC 17025, and
3. inspection reports issued by CAB accredited for ISO/IEC 17020.

The scope of conformity assessment is based on SGA regulation and technical requirements and is described in detail in this document.

These results shall be accepted if:

1. these reports cover the required SGA regulations and technical requirements,
2. the evaluation results are compliant, and
3. the CAB is accredited by an EA MLA signatory or an equivalent accreditation body.

1.1.8 Changes in certification scheme

The scheme document may need to be updated in order to address changes in SGA regulations and technical requirements, certification standards or due to any other reasons. Whenever the scheme document is updated, it will be communicated to the clients advising them about the changes and how these changes affect their certification.
